DIRECTIONS FOR USE

USE RESTRICTIONS: Use this product to repel Canada geese from golf courses and other turf areas. This product must be applied using appropriate spray equipment, such as a pump sprayer or a power-blast sprayer. Do not apply when grass is wet or rain is expected.

DILUTION DIRECTIONS:

Shake or stir Rejex-it® Migrate container well prior to diluting. Mix product outside or in a ventilated area.

Homeowners (i.e., application by hand or backpack sprayers): Mix Rejex-it Migrate with water at a ratio of 1 part product to 12 parts water. For example, mix 8 fl. oz. of product with 96 fl. oz. (3 qts.) of water to make 104 fl. oz. of spray mixture.

Specimen Label

Commercial users (i.e., application by boom sprayers): Mix Rejex-it Migrate with water at a ratio of 1 part product to 20 parts water. For example, mix 2.5 gallons of product with 50 gallons of water to make 52.5 gallons of spray mixture.

APPLICATION DIRECTIONS:

Homeowners (i.e., application by hand or backpack sprayers): Apply at a rate of 104 fl. oz. of spray mixture (0.07 lbs. a.i.) per 1000 square feet of turf.

Commercial users (i.e., application by boom sprayers): Apply at a rate of 52.5 gallons of spray mixture (3.07 lbs. a.i.) per acre of turf.

Spray evenly on area to be protected to provide thorough coverage and allow material to dry before permitting human activity on the treated area. Repeat application in 4 days or as warranted by Canada geese activity. Do not mow treated area for several days after application.

STORAGE & DISPOSAL

PESTICIDE STORAGE: Store only in original container, in a dry place inaccessible to children, pets, and domestic animals. Store apart from pesticides, fertilizers, food, or feed that may cause cross-contamination from odor. **Store above 32°F.** Keep container closed when not in use.

PESTICIDE DISPOSAL:

[Homeowner: 2.5 gallon and smaller] If empty: Do not reuse this container. Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.

[Commercial users: 5.0 gallon and larger] Product or rinse water that cannot be used according to label instructions must be disposed of according to Federal or approved State procedures.
